



RMT call time for action



The RMT National Executive Committee will be giving London Underground two weeks notice of our intention to take action short of strike on the Northern, Victoria, Jubilee and Central Lines in regards to excessive track noise at multiple locations across the combine.

This action will commence at 00.01 hrs on October 10th.

We welcome the fact that London Underground have now accepted that the introduction of PV Track has created an excessive noise problem.

We welcome the fact that they have now agreed to rip up all Pandrol Vanguard track. We also welcome the fact that they have found an extra £10 million pounds to address the problem.

LU refuses to consider TSRs

However, following feedback and discussions with safety reps from the affected lines the latest solutions and proposals presented by LU were deemed insufficient with LU refusing to consider

TSRs and being unable to provide more acceptable timescales. Leaving drivers to endure excessive noise for an unspecified number of years is not a position your safety reps were willing to accept.

The excessive noise and the frustration and anxiety this causes to our driver members has left the RMT with no option to take action short of strike by implementing our own temporary speed restrictions at Pandrol Vanguard locations.

RMT will, as always, remain available for further talks to try to find an acceptable solution to this problem.
